- d) Web Officer No written report was submitted due to illness. - e) Treasurer's Report: Liz highlighted a couple of items from the treasurers written report:
 - Our bank account was targeted by fraudsters on three occasions we have not lost any money and the bank paid out £100 compensation.
 - We have proposed to lower our subscription rates from £35.00 to £30.00, this is in line with other Morris Organisations, as this we are currently running a profit and want to pass this onto our members. Teams will need to change their standing order to reflect this. All the details will go out to members in their renewal notices.
 - Mileage rate change from 25p to 45p in line with HMRC due to fuel costs increase. The need to pay travel expenses has declined due to zoom

meetings, while the cost of fuel has gone up so hopefully the actual cost will balance against past expenditure.

South West – Sam Davey – Visited Sidmouth and has helped out online, looking forward to getting out more next year.

South Central – Clare Mach - Due to limited dancing with own side, has not met many members this year, but Isle of Wight teams seem busy. Has also sent out emails out to member teams and not received responses.

Central – Jen Cox - our area is getting back to normal, almost to prepandemic levels. It's a busy area with lots of teams and things are healthy here.

South East – Chris Lamb – Likewise limited response to emails, but most teams in the area are getting back to being busy, and two teams have done very well recruiting, through word of mouth and dancing out locally.

East Anglia – Robin James – Fenstanton have been busy, enjoying the Liverpool JMO DoD and recruiting some new members, things are almost back to normal.

There was a group discussion around recruitment issues, highlighting the following points:

Erstwhile, a new team have tripled their membership in a year and are a lovely success story.

Motion 1 – Brief clarification of definitions in preamble text.

Motion 2 – This motion was proposed due to the change to online meetings and online voting. Norm Warren, who was instrumental in the compilation of the current constitution, pointed out that the proposed wording contained an error in giving the Chair a casting vote on Constitution Motion votes, as these must be passed by a 2/3 majority. The meeting agreed to accept advance votes cast on this motion with the removal of the final sentence in the proposed 13. C). It was suggested we review the functionality of this system after next year's AGM.

Motion 3 – To bring the constitution into line with current practice regarding bank signatories, and to remove the inferred restriction on terms of service for officers. There was some discussion around this, and it was made clear that our current set-up (Jen Cox as Chair, Liz Scholey as Treasurer, and Nicki Pickering as Area Rep and ex-Chair are our current signatories) – when we looked into having a fourth signatory added we were told by the bank this amount of signatories would be irregular. **Action:** Should anything change with the bank account, or personnel, this would be subject to review.

13. Joint Morris Organisations Business:

Days of dance

- The 2023 JMO DOD will be hosted on behalf of Open Morris by Beltane Border in Exeter. Liz Wozniak spoke about plans for the day, which include some beautiful historial dance spots, evening events, and a Sunday tour for those interested. At the time of the meeting applications were not yet open, however you can now apply to attend by contacting chair@open-morris.org.
- The JMO are also planning Regional DoDs in the Autumn, to celebrate the 20th Anniversary of the first DoD in Trafalgar Square. There will hopefully be an event within easy travelling distance for most teams. We will send out information about these events as it becomes available.

14. The Sue Dyke Award

The competition, aimed at young people within Open Morris, has been going for 5 yrs now. The first competitions attracted good engagement, but since the pandemic there has been no interest. There is currently £1550.90 in the fund, after generous donations. The committee proposes that we open the competition up to members of all three Morris Organisations, to draw from a wider pool of potential entrants. Representatives of The Morris Ring and The Morris Federation received this suggestion well, and it will be discussed further at a JMO meeting.

15. The Doug Pickering Memorial Fund

This stands at £168.80. New teams can apply for grants of up to £50 to purchase equipment and kit. Please contact us via email if you are interested in applying to the fund.

16. Item for Discussion: Diversity in Morris and Wider Aims

Liz Scholey introduced the JMO working group (Equality, Diversity and Inclusion, known as EDI) which was set up to address recruitment issues, and has concluded that he issues of recruitment, diversity and the public perception of morris are fundamentally linked. Whilst wishing to celebrate the diversity that does exist within the Morris world, the group is working to network with other organisations promoting traditional dance, with EFDSS as a starting point. Eammon Andrews of Old School Rapper spoke about encouraging diversity by broadening the range of dance styles within Open Morris and expressed interest in the project going forward.

EDI papers are not being publicly released but are available to anyone who wishes to see them, please contact Liz Scholey.

The discussion broadened to recruitment tactics in general, with some interesting points about how groups advertise to recruit. Advertising 'dance lessons' could be taken more seriously and suitable members may self select.

Cindy Forster of Erstwhile Border Morris reported an incident of racially motivated behaviour from a member of the public towards a non-white member of their team, and wanted to make teams aware of the possibility of this. The meeting agreed that it was good practice to have policies in place within any organisation to address these issues should they arise.

17. Any Other Business

Chair did not invite AOB items as the duration of the meeting was nearing 3 hours.

18. Date and format of next AGM:

The proposed date of the next AGM is 19th November 2023. The Committee feel that a zoom AGM has many benefits, and the meeting agreed with this, however steps must be taken to ensure the format is accessible to the majority of the membership.
