- Our subscription rates will remain the same, to keep in line with The Morris Federation. All the details will go out to members in their renewal notices.
- We have added a rate for electric vehicles claiming mileage on expenses, this is set at 9p per mile in line with government guidance.

**12. Joint Morris Organisations Business:**

- Days of Dance  
The very successful 2023 JMO DOD was hosted by Beltane Border Morris on behalf of OM, in Exeter on April 23<sup>rd</sup>. In addition, Autumn regional events took place in Belper, Norwich, Chester, Bath, Newcastle and finally London, to celebrate the 20<sup>th</sup> anniversary of the exemption to the licencing act that made a significant impact on the course of morris history. Reports on these events will be made in the upcoming magazine edition. OM would like to extend hearty thanks and congratulations to the organisers of all the 2023 JMO events.

Bookings are now open for the 2024 JMO DoD, which will be hosted by Trentside Holmes on behalf of The Morris Federation in Newark on Saturday 13<sup>th</sup> April.

- Insurance: the JMO insurance policy for 2024 will be modified from previous years and will include Personal Accident Insurance for all team members alongside the usual Public Liability Insurance. This will mean a significant overall saving and less admin work and was received positively by the meeting. Michael Stimpson was thanked for his hard work in administrating the JMO Insurance policies.
- The JMO EDI panel has recently delivered a paper to the Vaughan Williams Memorial Conference on the subject of the use of songs as part of morris performances. This was well received, and will be the subject of magazine articles and website posts in the new year. The panel, which consists of representatives of all 3 JMOs, would like to invite people to get in touch via [edi@thejmo.org](mailto:edi@thejmo.org) if they have any suggestions, comments or issues to discuss surrounding Equality, Diversity and Inclusion in morris.
- Trust Registration Service requirements: Ed Worrall, JMO Legal Adviser, has prepared a document detailing a requirement for any organisation that holds funds to register with HMRC. This advice is being issued by each organisation in the JMO as the law does affect morris teams as things stand. See appendices for this document, which is also on the Open Morris website.

### **13. The Sue Dyke Award**

After opening up the 2023 competition across the whole JMO, we're pleased to report that two young people have been named as joint winners, receiving £75 each and a 6 month custodianship of the tankard engraved with their names. Both entries had video elements that were shown during the meeting, and these will be posted on the OM website in due course. The theme was 'From Rags to Ritual', and the winning entries were a broom dance and accompanying poem, and a piece of artwork depicting different kits. Despite the success of this year's entrants, it seems that the current format of the competition may have run its course, and there has been some interest in a nomination/recognition style competition which was discussed as a potential avenue for the competition in the future. It was resolved to keep the competition open to all those in the JMO who meet the age criteria.

### **14. The Doug Pickering Memorial Fund**

This has received no applications this year, and stands at £168.80. New teams can apply for grants of up to £50 to purchase equipment and kit. Please contact us via email if you are interested in applying to the fund.
